

Custom incentives

Custom incentives are available to businesses who install qualifying energy efficiency projects that are not eligible for rebates through other energySMART offerings.

Custom incentives are based on the therms saved from the energy efficiency project:

Project Savings	Incentive Amount	Incentive Cap*
2,500 - 15,000 therms saved/year	\$0.75 per therm saved	\$500,000 per year
> 15,000 therms saved/year	\$1.00 per therm saved	



Multi-family

The building has permanent or semi-permanent residential tenants and is an apartment/condominium, college/university dormitory, assisted living facility or retirement community consisting of 5 units or more, with a bathroom and kitchen in the unit.

2,500 - 7,500 therms saved/year	\$0.75	\$500,000 per

> 7,500 therms saved/year \$1.00

Small business

Business uses less than 60,000 therms of natural gas annually, is independently owned and operated, and has fewer than 10 locations

> 2,500 therms saved/year	\$1.25	\$500,000 per
	per therm saved	year

^{*}Incentives cannot cover more than 50 percent of the project cost.

Common projects include:

- · High-efficiency burner, boiler or furnace replacements
- · Burner and furnace controls
- · Process heat recovery technologies, including flue stack and condensing economizers
- · Regenerative thermal oxidizers
- Condensate return system improvements

- Direct-fired heaters
- · Destratification fans
- Air side measures: make-up air units or energy recovery ventilators
